## **CAREER OPPORTUNITY**

### **Recruitment Notice for appointment of Community Health Officer (CHO)**

**Advt No. – 01/2018(CHO)**

Jharkhand Rural Health Mission Society invites application from suitable candidates for filling up position of CHO (Community Health Officer) in health sub center to be converted into Health & Wellness Centers (H&WCs). Details of the vacant positions, remuneration, and number of post, desired qualification and experiences are mentioned herein below:

Candidates who are willing and enthusiastic to serve the community by bringing health care services to the doorsteps of the community shall apply for the post of Community Health Officer (CHO). The selected candidate has to undergo 6 months Bridge Course Programme in Community Health. This Course is part of an initiative under the National Health Mission to strengthen Sub- Centres as Health & Wellness Centres (H&WCs). Candidates after selection will have to successfully complete this course only then he/she will be posted as CHO at designated health centres. The CHO has to lead the primary health care system of designated Health & Wellness Centre consisting of a team like frontline workers such as the female health workers (ANMs), male health worker (MPW), and ASHAs.

#### **Essential Eligibility Criteria:**

- General Nursing and Midwifery (GNM) RNRM from a recognized Institute/Bachelor of Science in Nursing from a recognized Institute/University.
- At least 2 years of relevant work experience in the health sector.

#### **Desirable Criteria:**

- Proficiency in regional/local language and dialect.
- Work experience in the public health system, preferably at the Primary/Community Health Center level.

**Remuneration/Honorarium :** Maximum up to INR 40000.00 ( INR 25000.00 fixed + additional INR 15000.00 will be admissible as performance based incentive after posting as CHO).

**Mode of Selection:** screening process and shortlisted candidates will have to undergo a written examination.

**Number of Vacancy : Unreserved -105, Scheduled Cast-21, Scheduled Tribe-55, Extreme Backward Class (BC-I) -17, Backward Class (BC-II) -12 = Total 210**

The number of vacancies may vary and subject to the number of centres getting recognition from IGNOU.

#### **General information and Instructions:**

- i. The appointment will be purely on contractual basis for a period of one year, renewable subject to satisfactory performance. Any claim for absorption in the regular position shall not be entertained in future.
- ii. Society reserves the right to cancel any or all positions at any stage of recruitment process. Number of Vacant position may vary as per requirement/recognition of program center.
- iii. If at any stage of recruitment, it is found that candidate does not fulfill the eligibility criteria and/or that he/she has furnished incorrect/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled. The decision of the Society in any matter relating to the recruitment at any stage of the recruitment process will be final and binding upon the candidates.

Note - BC-I – Extreme Backward Class, BC-II – Backward Class, ST – Scheduled Tribe, SC – Scheduled Caste, PH – Physical Handicapped

The above age limit has been fixed as per Govt. of Jharkhand Circular no. 2096 dated 25.4.2011 Reservation policy of Govt. of Jharkhand will be applicable.

- v. Candidates of Jharkhand state who are claiming reservation in their respective category (ST, SC, BC-I & BC-II) have to submit the Caste Certificate in the prescribed format issued by SDM/ DC of Jharkhand state. For Divyang candidates reservation rules will be followed as per state govt. rules.
- vi. JRHMS will provide support for boarding and lodging allowances; IGNOU Fees, transport for practicum, and other training related costs. Apart from this, candidates will receive a fixed honorarium / stipend during the training period.
- vii. Please note the May 01, 2017 shall be taken as reference date for computing experience, age, qualification etc.
- viii. Eligible candidates may submit their application for the Post of CHO through online or send by Indian Post to the address below or before 19<sup>th</sup> May 2018 mentioning clearly "Application for CHO" on the center top of the envelop. Documents to be submitted include (a) an application form (b) curriculum vitae and (c) copies of qualification, Nursing council registration and experience certificates.
